

## **COOKIES POLICY [www.reservasfuerteventuraoasispark.com](http://www.reservasfuerteventuraoasispark.com).**

### **1. CONTENT AND CONFORMITY.**

---

This is configured as Cookies Policy (hereinafter, the “**Cookies policy**”) applicable to the website [www.reservasfuerteventuraoasispark.com](http://www.reservasfuerteventuraoasispark.com) (hereinafter, “the **Website**”), in which the supply of products and services offered is published MUSEO DEL CAMPO MAJORERO, S.L., allowing the acquisition by professionals (retail travel agencies and tourism intermediaries) Ticket / online tickets to the park OASIS PARK FUERTEVENTURA ubicado en Carretera General a Jandía, Km. 17, s/n C.P. 35628 La Lajita – Pájara (Fuerteventura, Islas Canarias, España), Including a visit to the Botanical Garden of the same, and the purchase of tickets / tickets online to enjoy special experiences and other activities in the park.

“**User**” is the person accessing, using, browsing or hiring the services and/or products offered, free or paid, through the Web Site, they must hold, to register on the website and make purchases online through it the condition of retail travel agency or tour intermediary who will act as commercial entities through their legal representatives or authorized persons directly or as freelancers, providing the corresponding number of current license (It can henceforth refer to the generic singular as “**Professional**” and plural “**Professionals**”), providing the corresponding number of a current license. Therefore, the user who registers will not be considered, in any case, consumers under the definition established by the General Law for the Protection of Consumers and Users.

Full legal information Web Site (hereinafter, the “**Complete Legal Information**”) is formed on a joint basis, they constitute a unit, the text contained herein ([Cookies policy](#)), and in the [General conditions of contracting online](#) (in case of purchase of tickets/entries online), in the [Privacy Policy](#) and in the [Legal information](#), which can be accessed directly via a link at the bottom of the Web Site (hereinafter, All documents referred to collectively as the “**Complete Legal Information**”). Consequently, the interpretation and consideration of the Information on the Legal Website must be carried out jointly by all the mentioned documents.

Access, use and navigation of the Web site by the user, as well as buying online ticket /entries implies your express consent and its full compliance with the entire contents of the so-called “Complete Legal Information” (Legal Information document including conditions of access, use and navigation, document general conditions of contracting online, Privacy Policy document and Cookies Policy document), so if you do not agree with any of the terms set forth in these documents, please do not provide us with personal data or use the Web Site or any services made available on it, or carry out the User registration and purchase tickets /entries online.

### **3. DEFINITION AND FUNCTIONING OF COOKIES.**

---

A "cookie" is a file that is downloaded to your computer, smartphone, tablet or TV when accessing certain web pages in order to store data that can be updated and retrieved by the entity responsible for installation. These cookies can allow a website, among other actions, to store and retrieve information about browsing habits of the user and their computer, depending on the information they contain and how your computer is used, they can be used to recognize the user.

Cookies from a technical point of view allow web pages to work more agile and tailored to your preferences, it can also help those responsible for the websites to improve the services they offer, thanks to the statistical information collected through the same.

### **4. COOKIES USED BY THE WEB SITE WWW.RESERVASFUERTEVENTURAOASISPARK.COM.**

The website ([www.reservasfuerteventuraoisspark.com](http://www.reservasfuerteventuraoisspark.com)) uses own and third party cookies, considering own and third party cookies they serve the following definition:

- Own cookies: those that are sent to the computer or terminal that access the Web site from own domains managed by our part or equipment and from which you request services.
- Third Party Cookies: those that are sent to the computer or terminal that access the Web site from a computer or domain not managed by us but by third parties dealing with the information obtained through cookies.

On the Website you can install third-party cookies that allow you to manage and improve the services they offer, being those listed in the table in this paragraph.

We also use session cookies and persistent cookies:

- Session Cookies: are temporary cookies that are installed in the cookies file of your browser only until you leave our web page.
- Persistent cookies: are cookies that are stored on the hard disk of the terminal which has accessed our website and can be accessed and treated for a period of time defined by those responsible for the cookie.

## **5. SERVICES PROVIDED BY THIRD PARTIES AND THIRD PARTY COOKIES.**

## **6. ACCEPTANCE OR NON-ACCEPTANCE OF THE USE OF COOKIES.**

Some cookies need to be installed on your computer to ensure the proper functioning of our Web site, but they can be disabled.. You can see them in paragraph 4 above identified as "strictly necessary".

Your consent to the use of cookies on our Web site will be requested at the time of access. It will show a window with the following: *"We use our own cookies to facilitate and optimize navigation (Session cookies to control Javascript enabled and to control persistent or non-acceptance of cookies and keep the user session remembering your login), as well as third-party persistent cookies to collect statistical data about your visit with the aim of improving our services by analyzing navigation performed by our users (Persistent cookies Google Analytics, owned by Google, Inc., California, EE.U.U.). Your consent is prior to the installation of any cookie. If you continue and browse the website, we consider that consent to the use and installation of cookies from the website; if not consent, do not continue browsing and no cookies are installed. For more information about their consent or how to change settings and uninstall your cookies, see our [Cookies policy](#)",* including a button to "Accept" and a button for "Not accept". There is also has a direct link access to that "Cookies Policy" at the bottom of our Web Site.

At the time of your access, you can explicitly indicate acceptance or not of the use of cookies for which we need your consent (by clicking the "accept" or "not accept" button). If not expressly stated their acceptance or non-acceptance, but continue browsing, for example using the scroll bar or clicking on any link, we believe that consents to the use and installation of cookies from our Web Site.

If expressly accept the use of cookies by action of clicking the "Accept" button or by any of the actions set forth in the preceding paragraph which means its acceptance, You may revoke this consent at any time through the deactivation or disabling of cookies according to what is available in the following paragraph 7. The revocation of consent will entail the same consequences as if you had initially pressed the button "not accept", so it will apply the provisions of the following paragraph in this regard.

In the event of not expressly accepting the use of cookies by the action of clicking on the button "Not Accept", it could have an impact on your browsing on our website, generally, they can not remember your session data or acceptance or cookies, besides not counting his visit in the analysis of cookies provided by third parties (in this case, Google Analytics).

You can always configure your browser to allow, prevent or eliminate the use of cookies, for which we provide some information on how to do this in the following paragraph 7.

We do not catch any personal data about our users, such as your IP address, password, data on your credit card or any other data in the cookies that we use.
